AGM

The AGM was held virtually also on the 19th September with approximately 37 members present.

An updated SVS constitution had been circulated prior to the meeting and the new constitution was agreed at the AGM. The BVA were sent a copy and were content with this.

The treasurer Tricia Sutton reported that the accounts were in a healthy position due to funds from the international meeting but that the society was running at an annual deficit. There is a need to ensure that conferences do not lose money and that new members are recruited. Membership fees have not been increased for 10 years but a lot of members are not paying the correct amount. Members were advised to check that they were paying the correct amount (£75) by standing order.

New Office Bearers for 2020/2021:

Nick Hart thanked Davinia Hinde and Moyna Richey, the retiring committee members, for their input to the society over the past three years. Retiring Senior Vice President Yoav Alony-Gilboa and secretary Heather Stevenson were also thanked for their years of service. Hazel Rice was thanked for her ongoing support and hard work as the SVS secretariat.

The president for 2020/21 will be Amanda Carson. Rebecca Mearns was confirmed as Junior Vice-President: Rudolph Reichel was confirmed as the new secretary: Tricia Sutton will remain as treasurer for 2020/21. There were 3 nominations for committee members and short biographies were presented. After a poll Shona Mouncey and Ed Hill were elected and welcomed onto the committee.

Nick Hart SVS president gave heartfelt thanks to everyone for supporting him during a difficult and at times challenging presidential year. He expressed sadness that the two conferences proposed for Belfast and Cheltenham during 2020 had to be cancelled but it is hoped that 2021 may allow the resumption of conferences. There followed a virtual handing over of the chain of office from Nick to Amanda.

Conferences

We continue to make tentative plans for the following conferences: Spring 2021 Cheltenham 24th – 26th May 2021 The autumn 2021 conference potentially to be held in Penrith Cumbria.

10th International Sheep Veterinary Congress (ISVC)

The 10th International Sheep Veterinary Congress (ISVC), that was scheduled to be held in Seville from September 20 to 24 2021 together with the 5th triennial Congress of the ECSRHM will be postponed to **March 6 to 10, 2023**, see copy of the letter at the end of this news-letter.

A global view of small ruminant production gives a fascinating and truly global insight into the daily lives of vets, livestock keepers and the sheep and goats in their care. Featuring over 400 images and accompanying texts from over 50 countries, this collection was first displayed at the 9th International Sheep Veterinary Congress in Harrogate in 2017.

BVA Consultations

The SVS executive committee have contributed to a number of BVA consultations this year including:

Under care and the remote provision of veterinary services

Regulatory reform - Embracing the vet-led team; Enhancing the VN role; Assuring practice regulation; Fitness to practise and standard of proof; Modernising RCVS registration

Consultation on improvements to animal welfare in transport a small group convened in December to consider a response to this Defra consultation and an equivalent Scottish Government consultation. While the proposal focuses on banning live animal exports it also considers radical changes to animal transport which could significantly impact on sheep farmers – for example the proposal to ban movements of sheep when temperatures are below 5 degrees C.

SHAWG

The fifth Sheep Health and Welfare Group (SHAWG) conference took place on Tuesday 24 November 2020 via an online conferencing platform. This was the final SHAWG conference as SHAWG is replaced with the new Ruminant Health and Welfare Group RHAWG.

The 2020 conference had the theme of working together for world-leading health and welfare and focused on target areas for the sheep industry to ensure it is ready for the challenges ahead.

Launch of two new sheep disease monitoring schemes by Scotland's Rural College's (SRUC) Premium Sheep and Goat Health Scheme (PSGHS).

The new monitoring schemes will sit alongside SRUC's PSGHS Accreditation Schemes providing a further level of assurance for buyers looking to reduce disease risk. The new schemes will monitor levels of two important infectious sheep diseases: Maedi Visna (MV) and Johne's disease, with potential for other diseases to be added in the future, diseases often known as 'Iceberg diseases' for the hidden risk they often pose for commercial sheep flocks.

Export Health certification (EHC) and OV training

From 1 January 2021, an Export Health Certificate (EHC) — a document that confirms an export of live animals or animal products meets health requirements — will be needed to export to the EU. The same level of certification will also be required for the export of live animals and animal products from Great Britain to Northern Ireland. This is a requirement under the agreed Northern Ireland protocol and includes equines that currently move between France, the UK and Ireland without health certification.

In October the UK Government announced a £300,000 training fund for vets and local authority officials to support the increased demand for Vets required to sign these certificates. <u>http://apha.defra.gov.uk/documents/ov/Briefing-Note-3220.pdf</u>

Red Tractor – Livestock Collection centres, Livestock Markets approvals

Over the last 6 months Nick Hart has months been involved with reviewing and amending beef and lamb flock health standards. This is now going out for consultation and any further changes would come into action October 2021. It is likely there will be stricter requirements and more responsibility for vets involved.

New project to support antibiotic stewardship in farm animals

RCVS Knowledge is to lead a major collaborative project to unite and empower UK farm animal vets and their practice teams to establish and embed good antimicrobial stewardship.

The Farm Vet Champions project will support farm animal veterinary professionals in continuing to improve animal health and welfare standards, and aims to provide inspiration and leadership towards One Health efforts. It is also a key initiative within the Responsible Use of Medicines in Agriculture (RUMA) targets set to be delivered by the UK cattle and sheep sectors by 2024.

In the first phase of the project, which is funded by the Veterinary Medicines Directorate (VMD), RCVS Knowledge will bring together representatives from major organisations including the British Veterinary Association and its farm animal specialist divisions to create free evidence-based species-specific online learning packages under the clinical leadership of Fiona Lovatt, RCVS Recognised Specialist in Sheep Health and Production and a diplomate of the European College of Small Ruminant Health Management.

The training, which will be freely accessible to all who sign up to become a Farm Vet Champion, will cover all types of food-producing animals encountered by farm veterinary professionals as well as provide modules on communication skills, particularly with respect to farmer attitudes, behaviour and compliance. Veterinary practitioners who engage with this project will be given access to all the tools necessary to empower them to make positive steps towards further improving antibiotic stewardship within their practices.

Antibiotic Guardian Awards 2020

North Park Veterinary Group in Devon was the overall winner in the "Animal Health, Agriculture and Food Supply" category in the 2020 Antibiotic Guardian Awards.

On receiving the award SVS member Jonathan Hobbs said "I hope that the lessons we learned with regard to successfully changing farmer behaviours can prove helpful to other vets. As indicated by the recent [Responsible Use of Medicines in Agriculture Alliance] report, we are certainly not alone in significantly reducing our usage of antibiotics in farm animals, and this award is good news and recognition for the whole profession."

SCOPS Launches 2020 Technical Manual Update

Following an expert review and comprehensive update, the new 2020 on-line version of the SCOPS Internal Parasite Technical Manual for Vets and Advisers went live on Monday 28th September. The new format allows access to all sections using a navigation tree, including links to additional documents. This means that users can access the information they need quickly and easily and when sections are updated they will be flagged, enabling users to keep abreast of developments in SCOPS science and practice.

In anticipation of these changes SVS will aligning our objectives by setting up a new website, creating new training webinars and reviewing the format of SVS conferences to help deliver these objectives.

Dear colleagues,

We would like to inform you that the 10th International Sheep Veterinary Congress (ISVC) that was scheduled to be held in 2022 from September 19th to 23rd, in Seville, together with the 5th Congress of the ECSRHM, will be delayed six months, to **March 6 to 10, 2023**. As it is known, the ISVC is being organized by the Spanish Society for Sheep and Goat Production (SEOC). The organizing committee has been working hard for several years in order to perform a successful conference at the organizational, content (scientific, cultural and recreational aspects) and attendance (delegates and speakers) levels.

The reason that has led us to make this decision has been the postponement of the 31st World Buiatrics Congress (WBC) 2021-MADRID, to September 4-8, 2022. The situation caused by the COVID-19 pandemic has forced the organizers (the Spanish Society ANEMBE) to postpone the conference to September 2022.

As we said before, we would like to have a successful ISVC congress, and as you know, although the WBC is a congress eminently dedicated to cattle, it also has a section dedicated to small ruminants. The WBC is an event with which we share delegates, speakers and members of the Scientific Committee, so it is likely that by holding both events at such close dates, many potential participants, would be forced to choose between the two congresses, negatively affecting both the number of attendees (delegates) and the quality (speakers). We also share sponsor companies and institutions, so holding both congresses in the same year and in the same country, would negatively affect their financial support to our congress. For these reasons, after taking into account the opinions of the members of the Organizing and Scientific Committees of the ISVC-Seville, and obtaining the ISVA and ECSRHM approvals, we considered postponing it to March 2023 to be the best option. If this postponement could cause inconvenience to any delegate, we sincerely apologize on behalf of all the organizers.

We also want to communicate, that we have decided, together with the ISVA, to organize a **virtual meeting** from 23rd to 25th November 2021 of which we will inform you soon.

Looking forward to meeting all you in March 2023 in Seville!!
