# **BVA consultations**

#### Welfare in transport

The committee brought together a group to formulate the response to the Defra and Scottish Governments consultations on Welfare in transport which included: Willie Stewart, Nick Hart, Rebecca Mearns, Clare Phythian, John Royle, Peter Baber, Julian Earl, Bill McKinney, Rudolf Reichel, Amanda Carson & Kate Hovers.

These consultations originally focussed on the Governments manifesto commitment to ban live animal exports but then brought in other considerations on welfare standards for livestock during transport including a suggestion to prevent animals being transported when temperatures are below 5 degrees!

This group felt that there had been a missed opportunity especially in paying due regard to scientific evidence regarding the relationship between journey times and welfare outcomes and that animals slaughtered for food should be slaughtered as close to the point of production as possible.

#### **Red Tractor review**

Nick Hart was a member of the Red Tractor review group and was able to feed in very practical considerations. He is currently assisting with the review of the consultation responses.

#### **Animal Sentience**

SVS were a signatory to a letter from BVA to the Telegraph calling on Govt to take swift action to embed the principle of animal sentience in law (its 40 months since they made this commitment!). <u>https://www.bva.co.uk/news-and-blog/news-article/leading-vets-vet-nurses-and-students-call-for-urgent-action-on-animal-sentience</u>

The BVA have had numerous meetings to also consider Covid-19, the RCVS Consultation on the Legislation Working Party recommendations and other issues.

#### **FUTURE FARMING**

Within Defra, the Future Farming and Countryside Programme has been developing a number of animal health and welfare reforms. These reforms are centred on a new Animal Health and Welfare Pathway that will strike a new deal with government and farmers, be industry led and will allow us to work together to continually improve farm animal health and welfare. The Pathway will promote the production of healthier, higher welfare animals at a level beyond compliance with regulations and will underpin our high international reputation for animal health and welfare.

**Animal Health Pathway** – work continues to develop ways to provide support in England to control endemic disease. BVA divisions have recently been included in sub groups which are exploring these proposals – especially with regard to vet visits to farms.

#### Welfare

Payment-by-results centres on making ongoing payments to farmers that deliver demonstrable welfare enhancements that are above the regulatory baseline, valued by the public and not sufficiently provided by the market.

Defra have commissioned the University of Bristol, ADAS and the Royal Agricultural University to undertake research on **The Economics of Providing Livestock with Health and Welfare Enhancements via a Payment by Results Scheme.** This research started on 1st September 2020 and will run for 18 months. Six sectors will be covered: Laying hens, meat chickens, dairy cattle, beef cattle, sheep and pigs.

Animal Welfare Payment-by-Results Workshop 11th December 2020

Attended by Rudolf Reichel, Amanda Carson and Rebecca Mearns and some interesting discussion followed some of indicators suggested:

Freedom from discomfort:

When housed deep bedding and portioned areas are provided; Low levels of dirtiness; Choice of temperature/ shelter from extreme weather

Freedom to Express Normal Behaviour: Promoting positive experiences:

**Choice** of food enrichment is provided e.g. two or more forms of roughage, whole crop, diverse swards; **Choice** of environmental enrichment is provided, e.g. novel piles of logs, climbing hills; Ewe and lambs remain together for at least 16 weeks

Freedom from Pain, Injury or Disease:

Use of genetic strains that promote longevity and physical robustness; Low levels of lameness; Keeping lambs with intact tails; Providing prolonged analgesia for tail docking; Keeping lambs uncastrated; Providing prolonged analgesia for castration; Low levels of lamb mortality;

Freedom from Hunger and Thirst Low levels of ewe mortality; providing a 100% pasture-based diet and good body condition;

Freedom from Fear and Distress

Sheepdogs are limited to use on open land, not around housing or handling pens; Sheepdogs not used. Sheep moved by following or calling or other form of positive reinforcement used; Stable social groups are promoted through retaining young-stock on farm and limiting mixing of groups; Gradual weaning/ natural weaning practiced
