4) Farm Vet Champions phase 2

- a) VetTeamAMR Project Manager demonstrated two user journeys through the prototype SMART goal tool (presentation attached for reference)
- b) There was positive feedback across the group.
- c) Suggestions included:
 - i) Promotion to demonstrate ease of use without time demand
 - ii) Make an infographic of setting SMART goal for social media use
 - iii) Moodle allows the ability to share documents with other members in invite-only groups
 - iv) Diverse teams might be able to use this, for example stakeholder organisations in their efforts to increase FVC sign-up
 - v) VetPartners offered to provide a group of vets to pilot the SMART goal platform
 - xiii) Incorporation into Practice Standards Scheme (PSS)
 - xiv) There was some feedback that the platform might be seen as a tool for newly qualified vets only, perhaps as part of their development program. The group stressed that this is intended to be a tool for all. It was suggested that to overcome this perception, it would be important to use diverse range of role models, including those that have been qualified for 5+ years, to encourage use by all.
- d) Reminders of SMART goals can be set to weekly/monthly by users in their profile settings
- e) SMART goals are viewable by all members of the team but only if you have been invited to the team
- f) Superusers can add to the goal catalogue, for example if it becomes evident that certain goals are being commonly manually added by users
- g) Setting SMART goals is not mandatory
- h) SMART goals will be visible on a dashboard that will detail progress (can use for performance reviews)
- i) Currently the platform is on target to be launched to a pilot group at end March
