Update from the President

As I write this newsletter, parts of England are enduring drought conditions affecting crop yields and grazing, with cattle and sheep being buffer fed forage intended to get livestock through the winter. Hosepipe bans threatening green manicured lawns are the least concern for farmers. The impact of climate change on farming focusses the mind when considering the wider benefits of parts of the Environment Land Management Scheme (ELMS) funding for sustainable farming and local nature / landscape recovery. We will need to have greater involvement in preparing our farming clients for what the future holds and perhaps, in England, this starts with the Animal Health and Welfare Pathway vet visits, which are part of the Future Farming Programme. Similar schemes are planned for Wales, Scotland and Northern Ireland.

This dovetails nicely with some of the themes and presentations that we have in store for you at the Autumn conference, to be held 17 - 19 October at the North Lakes Hotel, just off the M6 in Penrith and within walking



distance of the train station. Details and booking form are included in this mailing.

The conference will start with a half day workshop exploring new ways to engage with your sheep farmers, technical skills for addressing common flock problems, including getting the data to measure improvements, and will be useful for all vets but especially for those in England preparing for Pathway vet review visits. During the conference, we have sessions on current welfare issues, the latest on endemic diseases including OPA and sheep scab, and a great selection of short

papers covering a wide range of topics. The Wednesday morning will be a not-to-be-missed visit to the farm of James Rebanks, sheep farmer, author and environmentalist, to hear about the changes made to the farm to embrace nature and biodiversity. Places are limited so get your booking confirmed asap! The AGM will also be held and any items for the agenda should be notified to the secretariat in advance please.

At the Belfast conference we raised over £300 for The Conservation Volunteers charity, through carbon offset donations and the raffle of the book 'Fasciolosis' kindly donated by John Dalton. At the Autumn conference we intend to raise money for VetLife, which celebrates the 30 year anniversary of its Helpline this year. For those at the Belfast conference the conversations that arose following Peter Hynes' sharing his own mental health struggles made it clear that we all know or have known someone within the profession who has experienced depression, and suicide is sadly not a rarity. The importance of asking for help and having somewhere to turn to that will not judge but can offer support when needed is what VetLife can provide. The 10th International Sheep Veterinary Congress (ISVC) – registration and submission of abstracts now open!

The **10th International Sheep Veterinary Congress** (ISVC) will be held in Seville, Spain, from 6th – 10th March 2023. The registration and submission of abstracts have recently opened, and you can find the details, along with the preliminary program, on the website: <u>https://isvc2023.com/index.php</u>



The deadline for the submission of abstracts is the 25th of September 2022, and for the early bird registration, the 1st of December 2022.

The program covers the main topics of interest for the current situation in the sheep sector: sustainability, tackling antimicrobial resistance and global threats to small ruminants. There is also a fourth stream organized by the European College of Small Ruminant Health Management (ECSRHM) and the Spanish society for sheep and goat production (SEOC).

The congress is a five-day event that includes five plenary sessions, more than seventy keynote presentations and nearly 300 oral communications. The social program will allow you to enjoy the most emblematic places in Seville. In addition, there are both pre-conference and post-conference tours available. The former is an eight-day event that will take you from the north to the south of Spain, visiting tourist attractions but also local sheep farms.

The post-conference tour will focus on Andalusia's main cities but will also include visits to Andalusian sheep farms. The organising committee is looking forward to seeing you all there!

'Sheep Meet' local meetings, supported by Ceva Animal Health

Executive Committee

At the Autumn meeting we say a huge thanks and farewell to Amy Jennings and Rachel Forster who have completed their 3 year stint on the committee. It's not really goodbye though as Amy has taken on the task of coordinating the conference proceedings and Rachel's opinion and expertise will still be sought particularly as she has been such a valued member of the Surveillance and Future Farming subgroup and will continue as the SVS representative on the Sheep Antibiotic Guardian Group (SAGG).

We will be seeking two new members to join the Executive Committee and expressions of interest should be sent to the secretariat in advance of the conference. Representation from different regions of the UK and different areas of veterinary work is good to have so we can offer opinion on the various consultations and industry working groups that benefit from our involvement. We are also seeking a new overseas representative and thanks go to Claire Phythian who has held this position in recent years. Expressions of interest to the secretariat please. Committee meetings are held online and there is scope for involvement in the working groups that are in your areas of interest. Speak to one of the current committee members if you'd like more information.

Following the Belfast conference, we now have a SVS representative on the BVA NI branch. Stephanie Winslow (who gave a great presentation on reducing antimicrobial use in neonatal lambs at the conference) has agreed to liaise between the 2 organisations on relevant matters and this can only strengthen the relationship for years to come.

Consultations and industry groups -

SVS have been involved in multiple BVA / RCVS consultations and industry working group meetings since the last newsletter including:

Animal Health and Welfare Pathway

SVS involvement in co-design of the Pathway has continued with representation at meetings of the various subgroups. Most recently these have reviewed the items in the capital grants scheme and the training resources that may be helpful for vets undertaking visits, particularly where this involves farm visits to less familiar species / management systems than their usual workload. The scheme is currently open to farmers for beta testing of the systems ahead of a full launch in Autumn.

Wales Sustainable Farming Scheme update meeting – to outline the timeline for the scheme ahead of launch planned for 2025.

European Medicines Agency (EMA) public consultation on prophylactic use of antimicrobials in animals. SVS provided a response broadly agreeing with the direction of travel but urging for a more gradual move towards restrictions to allow further progress to be made towards meeting RUMA targets. Examples of evidence gaps in best practice antimicrobial use were also given (e.g. infectious keratoconjunctivitis, joint ill) and concerns raised as to the possibility of compromised welfare in flocks arising from application of the guidance. A consultation covering similar lines is expected later this year from the VMD and SVS will aim to garner members views prior to submitting a response.

BVA survey on EMS for vet students - April 2022

OPA working group – Terms of Reference of the group cover practical and achievable ways to control OPA, feasibility for future schemes / certification and increasing awareness of OPA. There has been much discussion on transthoracic ultrasonography in control of OPA. This working group is ongoing but the importance of diagnosis as

an act of veterinary surgery in discussions on potential role of lay scanners has been a focus along with the paucity of competent vets offering scanning as a service.

Welfare

Tailing and castration discussions with Trading Standards and industry representatives Welfare In Transport Reforms Workshop: Maximum Journey Times for Cattle and Sheep – exceptions and discussion of application of EU legislation and how this will be translated into UK legislation.

Ruminant Health and Welfare Group – discussion of feasibility of pre-sale screening of sheep and discussion of the Shetland Islands Council template for disease screening.

Medicines

The RUMA Sheep Sector focus was earlier this month and the successes in reducing antimicrobial usage were showcased with plenty of social media activity from RUMA and involvement of NSA chief executive Phil Stocker, Fiona Lovatt (Farm Vet Champions Clinical Lead) and case studies from farmers and their vets. The Medicine Hub and the

importance of recording to measure usage to back up the more subjective evidence of responsible use was also highlighted.
